- Punjabi University Patiala (PUP) will provide centre-wise data (Roll numbers, Photos, Name, Exam date/s etc.) of all registered candidates to the Bidder. Bidder will then use this data for biometric authentication shall enable respective mechanism and candidate verification during the subsequent stages of the process.
- Bidder will have to install QR code scanner & Finger recognition, along with manpower at each & ev 2. Examination centre at the time of examination.
- Solution should have provision of real-time attendance monitoring system through secured web server.
- Bidder has to maintain the entire database and application server at two different seismic zones within In 3. 4. making one site as DC (Data centre) and other site as DR (Disaster recovery).
- QR code / Bar code containing roll number on the Admit card of the candidate should be scanned/read to a fetch the candidate details from Application Database (provided by PUP) and incase, QR/Bar code is missing 5. admit card, then manual entry of roll number with candidate information has to be made. Thereafter, finger recognition by the Hand-held device shall be done at the Security gate before the beginning of examination activities should be completed before conclusion of examination.
- Bidder should deploy de-duplication algorithm across the database to avoid the duplicity of enrollment record
